

The Corporation of the Township of Howick

By-law No. 53-2018

Being a by-law to appoint officials, members of committees and boards and other such persons as required

Whereas, the Municipal Act 2001, as amended, under section 228 (1) provides for the appointment of a Clerk; under Section 286 (1) provides for the appointment of a Treasurer and collector for the municipality; under Section 296 (1) provides for the appointment of one or more auditors; and under section 227 provides for the role of officers and employees;

And whereas, the Building Code Act, Section 3 states that the Council of each municipality shall appoint a Chief Building Official for the purposes of enforcement of the Act;

And whereas, under Section 196, as amended, conveys to a municipality the power to establish inter-municipal and intra-municipal boards and committees and to appoint representatives to carry out the assigned duties of their respective boards;
